AMENDMENT TO DECLARATION OF CONDOMINIUM
OWNERSHIP OF TOWN APARTMENTS, INC. NO. 1,
A CONDOMINIUM

This Amendment to Declaration of Condominium of Town Apartments, Inc. No. 1, A Condominium, made and entered this 2nd day of May, A. D. 1969, by the undersigned, being three-fourths (3/4) or more of the owners of condominium parcels contained in the aforementioned condominium at a meeting duly called for such purpose pursuant to the By-Laws of Town Apartments, Inc. No. 1,

WITNESSETH:

WHEREAS, the Declaration of Condominium of Town Apartments, Inc. No. 1, a condominium, recorded in O. R. Book 2096, page 613, Public Records of Pinellas County, Florida, contains at Paragraph 20 (j) certain requirements as to parking in the parking spaces so allotted, and

WHEREAS, the undersigned are desirous of amending said provision so it more clearly expresses the wishes of the owners of the condominium parcels, and

WHEREAS, a meeting was held for the purpose of voting on an amendment to Paragraph 20 (j) of the Declaration of Condominium Ownership of Town Apartments, Inc. No. 1, a condominium, on the 2nd day of May, A. D. 1969, and

WHEREAS, at said meeting it was agreed by the affirmative vote of three-fourths (3/4) or more of the condominium parcels to amend the Declaration,

NOW, THEREFORE, in consideration of the foregoing, it is hereby covenanted and agreed that Paragraph 20 (j) of the Declaration of Condominium Ownership of Town Apartments, Inc. No. 1, a condominium, shall be deleted in its entirety and amended to read as follows:

(j) Parking shall be limited to passenger automobiles or passenger station wagons in the parking spaces allotted, and designated for such purposes as provided for from time-to-time by Town Apartments, Inc. No. 1, a condominium, and the numbering on the parking spaces allotted as shown on the condominium plat are hereby deleted and removed.

All other terms and conditions of said Declaration of Condominium shall remain in full force and effect.
