No. 3, A condominium be amended to read as follows:

- (b) Keeping of Household Pets
- (1) Any owner having a pet as of the date of this amendment shall be allowed to keep said household pet until the pet dies, is lost or is no longer in the possession of the original owner.
- (2) Upon the death, loss or relinquishment of possession of the household pet of said owner, that owner shall not be permitted to replace said pet or keep a new pet.
- (3) Any owner having a household pet as of the date of this amendment shall not be allowed to keep an additional pet or a different pet.
- (4) Any owner, not having a pet as of the date of.
- (5) Upon a resale of any condominium parcel subsequent to the date of this amendment, the new owner having a pet shall be allowed to keep said pet subject to paragraph 1.
- (6) Any owner having a pet and same pet is being brought out on the outside, the said pet must be held on a leash and walked in areas provided for pets only.

All other terms and conditions of said Declaration of Condominium shall remain in full force and effect.
