WHEREAS, at such special meeting there was present a quorum as defined by the Declaration of condominium and the Bylaws for Town Apartments, Inc. #4

WHEREAS, after due consideration of said proposed Amendment, same was presented for a vote and accepted by vote of the Board of Directors, and said Amendment was approved by the three-quarters (3/4) required percentage of Unit Owners according to the provisions of the bylaws, Articles of Incorporation and the Declaration of Condominium for said Association;

WHEREAS, the Directors and unit owners of town Apartments, Inc. #4, hereinafter referred to as "Association" desire to amend the Declaration of condominium for said Condominium Association a Florida Corporation not for profit, which Declaration of condominium has been filed and recorded in and for Pinellas County, Florida, within OR. Book 2194 Page 358 Paragraph 18 sub paragraph (b) and (c) as follows:

(b) RENTAL OR LEASE, A condominium parcel shall not be leased or rented without the prior written approval of the Association, and the terms and conditions of said Lease are subject to approval of the Board of Directors of the Association. The Board of directors shall have the right to require that a substantially uniform form of Lease be used.

In the event the Board of Directors approves a rental or lease, such approval of a lease or rental shall not release the member from any obligation under this Declaration. Any such lease or rental shall terminate upon the conveyance of the membership and interest in a condominium parcel or upon the death of the leasee.

(c) CORPORATE PURCHASER: If the purchaser or leasee is a corporation, the approval may be conditioned upon the approval by the Association of all occupants of the condominium parcel.

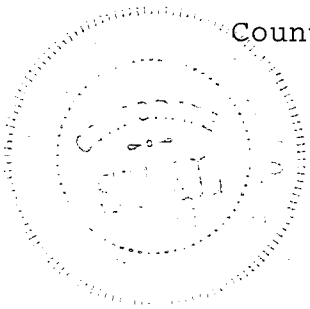

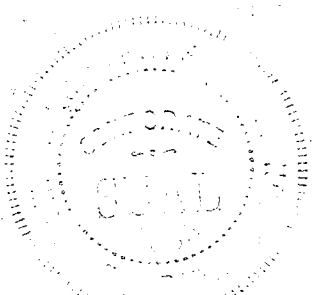
