THE FOLLOWING AMENDMENT TO THE BY-LAWS OF CONDOMINIUM NO. 6
OF TOWN APARTMENTS INC. WAS APPROVED AT A SPECIAL MEETING
HELD ON MARCH 7, 1989, BY THREE FOURTHS (3/4) VOTE OF ALL MEMBERS
OF THE CORPORATION AS REQUIRED IN THE BY-LAWS.
ARTICLE X SECTION E AS RECORDED IN THE OFFICIAL RECORDS
OF PINELLAS COUNTY O.R. BOOK 6496 PAGE 2345 READS AS FOLLOWS:
"NO PERSON UNDER THE AGE OF FIFTY-FIVE (55) SHALL BE PERMITTED
TO OWN OR LIVE AS A PERMANENT RESIDENT IN ANY UNIT OF CONDOMINIUM
--NO--6 EXCEPT WHERE THE PERSON IS MARRIED TO A UNIT OWNER.

THE ABOVE PARAGRAPH IS AMENDED BY ADDING THE FOLLOWING PARAGRAPHS:

"NO CHILDREN UNDER THE AGE OF SIXTEEN (16) YEARS SHALL BE PER-
MITTED TO LIVE AS A PERMANENT RESIDENT IN THE CONDOMINIUM UNITS,
PROVIDED HOWEVER, THAT NOTHING HEREIN SHALL PREVENT OWNERS FROM
HAVING CHILDREN AS VISITORS FOR A LIMITED PERIOD OF TIME."

TOWN APARTMENTS INC. NO. 6 IS DESIGNATED HOUSING

FOR OLDER PERSONS AND THIS HOUSING IS INTENDED AND OPERATED FOR
OCCUPANCY BY AT LEAST ONE PERSON PER UNIT WHO IS FIFTY FIVE (55)
YEARS OF AGE OR OLDER.

WE, THE UNDERSIGNED, AS DULY ELECTED OFFICERS OF TOWN
APARTMENTS INC. NO. 6, DO HEREBY CERTIFY THAT
THE ABOVE AMENDMENT WAS APPROVED AS STATED.
