WHEREAS, The undersigned are desirous of amending said provision so it more clearly expresses the wishes of the owners of the condominium parcels, and,

WHEREAS, A meeting was held for the purpose of voting on an amendment to paragraph 20 (b) of the Declaration of Condominium Ownership of Town Apartments, Inc. No. 14, a Condominium on the 30th day of September A. D., 1970.

WHEREAS, at said meeting it was agreed by the affirmative vote of three-fourths (3/4) or more of the condominium parcels to amend the Declaration.

NOW THEREFORE, In consideration of the foregoing, it is hereby covenanted and agreed that paragraph 20 (b) of the Declaration of Condominium Ownership of Town Apartments, Inc.

No. 14, A condominium be amended to read as follows:

(b) Keeping of Household Pets

(1) Any owner having a pet as of the date of this amendment shall be allowed to keep said household pet until the pet dies, is lost or is no longer in the possession of the original owner.

(2) Upon the death, loss or relinquishment of possession of the household pet of said owner, that owner shall not be permitted to replace said pet or keep a new pet.

(3) Any owner having a household pet as of the date of this amendment shall not be allowed to keep an additional pet or a different pet.

(4) Any owner, not having a pet as of the date of this amendment shall not be permitted to keep a pet.

(5) Upon a resale of any condominium parcel subsequent to the date of this amendment, the new owner shall not be allowed to keep a pet.

(6) Any owner having a pet and same pet is being brought out on the outside, the said pet must be held on a leash and walked in areas provided for pets only.

All other terms and conditions of said Declaration of Condominium shall remain in full force and effect.

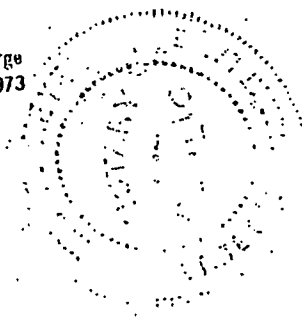

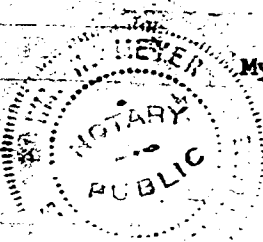
