Paragraph 18(b) of the Declaration of Condominium shall be amended, however, any and all remaining sections as contained within Paragraph 18 shall remain the same. Said Amendment is as follows:

(b) RENTAL OR LEASE: A Condominium parcel shall not be leased or rented. without the prior written approval of the Association, and the terms and conditions of said lease are subject to the approval of the Board of Directors of the Association and Coral Management Co., Inc. The Board of Dictors shall have the right to require that a substantially uniform of lease be used.

In the event the Board of Directors approves the rental or lease, such approval of a lease or rental shall not release the member from any obligation under this Declaration. Any such lease or rental shall terminate upon the conveyance of the members membership and interest in the condominium parcel or upon the death of the lessee.

(c) CORPORATE PURCHASER: If the purchaser or lessee is a corporation, the approval may be conditioned upon the approval by the Association of all occupants of the condominium parcel.
